## Criteria

The Ministry Initiative Grant (MIG) is an Atlantic Baptist Mission Board (ABMB) grant specifically designed to support churches and ministries that evidence concrete plans and specific strategies for obediently moving ahead toward reaching their potential for Jesus Christ and His Kingdom. Consequently, applications will only be considered if the following requirements are met. The application **must be from a CBAC church** that has:

1. a **clear, concrete vision** and **intentional strategy** for at least one or more of the following:
  - a. The renewal or revitalization of the church's ministry;
  - b. To become a healthy (or healthier) growing church;
  - c. To establish a specific outreach ministry in the community or beyond;
  - d. To reach the immediate community and beyond with the Gospel;
  - e. To establish a point of mission or plant a new church;
  - f. To begin a new ministry initiative or move the ministry of the church in a new direction
2. a **demonstrable financial need** that needs to be met for the vision is to be achieved,
3. been **approved by the respective Association** and includes their recommendation.

**Reminder:** The Vision of the Canadian Baptists of Atlantic Canada *is to join God in changing Atlantic Canada one neighbourhood at a time.* **Applications for a Ministry Initiative Grant should clearly demonstrate evidence of the church exercising this vision in their ministry plan.**

**Note:** When your application is completed, **two copies** must be sent to your Association Mission Commission (or equivalent). The Association must forward **one copy** to the Atlantic Baptist Mission Board **by November 13, 2026** (in preparation for MIG's review at the AGM of the ABMB) and **retain the other copy** for their records. **It is important that all information requested be provided.** Otherwise, consideration will be delayed.

## Ministry Initiative Grant Proposal

This need not be burdensome or seen as a “hoop”. Thinking through the following will serve you and your team as you prepare and anticipate launching your new ministry initiative.

The following are important to consider and integral to a successful proposal. (These questions and your proposal can be typed on a separate piece of paper.)

### WHAT...?

- ... is the new ministry initiative? Be crystal clear and specific.
- ... strategy will you use as you begin this initiative?
- ... will the new initiative look like? What will the approach be?
- ... steps are you taking and will continue to take to see this initiative become reality?
- **IMPORTANT: What are the exciting OUTCOMES that you anticipate occurring if this ministry initiative is “successful”?**

**WHY?** Make a compelling case and rationale for this new ministry initiative. Why is this new ministry needed? Include your “three-minute elevator talk” as a way to engage, excite, and energize others about this project. What will be the clear Kingdom impact if this initiative is “successful”?

**WHO?** Who is the target audience for this new ministry initiative? Who do you anticipate trying to reach or impact through this initiative? Who will be involved?

**WHERE?** Where do you see this new ministry initiative taking place? In what neighbourhood or location will this initiative have an impact? What could be the lasting effect in that neighbourhood?

**WHEN?** Timeframe. How do you see the timeline unfolding? (Is there a specific start and end to this initiative? Is there a hope that the initiative will carry on?)

**HOW? Include COSTS** How will this new ministry initiative get done? (People + Resources) Provide all financial information associated with the ministry initiative.

### Expenses

- Broad strokes of what the budget looks like for this initiative (i.e., not your church budget but a budget specifically for this ministry initiative)
- Staff related costs
- Costs associated with rental of equipment, resources, or facilities, etc.

### Revenue streams

- Other sources of income (grants, outside donations, etc) apart from an MIG?
- How much of this initiative will be funded by income (offering and/or fundraising) from the congregation?



**Additional Information:** Include any additional information that is strategic or helpful as it relates to this ministry initiative. For example, a community survey that reveals the need the church is addressing through this initiative.

**Return Grant Requests:**
